Sandata fixed an issue that was causing units reported to DODD for the date of 11/2/2025, the end of Daylight Saving Time (DST), on overnight visits to be short units. This fix went in on 12/17/2025. DODD claims area will be resubmitting claims that we have identified that were affected by this issue. The claims will be in the DEC25E cycle that will be picked up 12/24/2025.

We are pleased to announce an upcoming upgrade to the MSS application. Developed in response to stakeholder feedback, the new version offers a more streamlined, user-friendly interface and expanded capabilities to support service planning and coordination.

Implementation Timeline:

- Soft Launch (County Boards Only): January 8, 2026 - County Boards can begin transitioning active sites during this phase.
- Go Live (All Users): July 1, 2026
- Transition into MSS: December 31, 2026 – Vast majority of all individuals transitioned into MSS
- Legacy MSS Access: Available through July 2027 for edits to pre-July 2026 service dates
